We are still going forward with the fundraiser that the Grand Chapter and the Grand Court planned to assist with the conference. If we host in 2021, we will have extra funds. If we do not host, it will act as a fundraiser for the Grand Chapter. 1st Prize 70" Samsung Smart T.V. valued at \$600.00, 2nd Prize AirPods from the Apple Store valued at \$310.00, 3rd Prize is 100 lottery tickets at \$100.00. All tickets are \$5.00 each. Depending on the size of the Chapter/Court will determine how many tickets each Chapter/Court will receive.
